

# CORPUS CHRISTI UNITED STATES BOWLING CONGRESS END OF YEAR TRIO TOURNAMENT RULES

The tournament will be held on May 19, 2024 at Bowlero Corpus Christi. **Entries Due May 14, 2024.**

This tournament will be subject to all USBC Rules and Regulations unless otherwise specified.

## 1. ELIGIBILITY:

A. All adult members of the United States Bowling Congress (USBC) are eligible to enter.

## 2. FORMAT:

A. Tournament will consist of three (3) games.

B. Handicap will be based on an individual basis of 90% of 210.

C. Teams will consist of three (3) adult members of the USBC in any combination. **One bowler must have a 180 or below.**

## 3. TOURNAMENT ENTERING AVERAGE RULING: (Circle applicable rule on entry form)

A. Bowlers will use their highest 2022-2023 average of 21 games or more as listed on Bowl.com, or

B. a 2023 summer average of 21 games or more as listed on Bowl.com, or

C. if no 2022-2023 average on Bowl.com, bowler will use May 14, 2023 average of 21 games or more.

C. If options A, B, or C do not apply, bowler shall enter tournament with a 210 average.

**USBC Rule 319 WILL NOT enforced. Bowlers will not re-rated under Rule 319.**

## 4. TIME:

A. Squad time is 9:00 a.m.

B. Check-in will be one (1) hour prior to squad time.

C. If you have any changes in your line-up, please contact Tournament Director.

**NOTE:** Any bowler arriving late will begin play with score counting in frame that is being bowled. Bowler shall receive a zero (0) pin count for each frame missed, in the proper order of bowling. No absentee score or average will be used. The Tournament Director has the right to start squad prior to schedule time provided all bowlers are checked in and assigned lanes are available.

## 6. PRIZE FUND:

A. Prize fund will be paid at least one to five (5) ratio per event.

B. Entry Fee for Team is \$150 (\$50/person)

C. Break down of Entry Fee: \$12 Lineage; \$8 Association \$30 Prize Fund

**D. Based on 30 teams, 1st place will pay \$500.**

## 7. MISCELLANEOUS:

A. In the event of mechanical failures, affected bowlers will be moved to the next available pair of lanes.

B. Tournament computer will automatically assign lane assignments.

C. In case of tie, the prize money will be split equally between teams or individuals.

D. All participants shall have a 2023-2024 USBC Sanction Card at time of check-in prior to bowling. If not sanctioned, bowlers will be required to purchase an affiliate card before they are allowed to bowl.

**E. ALL ENTRY FEES MUST BE PAID PRIOR TO PARTICIPATION IN TOURNAMENT.**

**F. ALL DECISIONS OF THE TOURNAMENT DIRECTOR ARE FINAL UNLESS AN APPEAL IS MADE IN ACCORDANCE WITH RULE 329.**
